WE HAVE HAD GOOD RESULTS DURING THE EARLY D.H. SEASON WITH THIS FLY AND HAS ALSO WORK WELL ON FRESHLY STOCKED TROUT. I TIE THIS FLY WITH LEAD WIRE FOR EXTRA WEIGHT. FISH THIS LIKE YOU WOULD ANY NYMPH. THE BEST WAY TO TIE THIS I FOUND IS TIE ONE SIDE THEN THE OTHER (EGG YARN), OVER LAPPING THE YARN BACK TOWARD BEND OF THE HOOK AND TIE DOWN NEXT TO THE BEAD. THEN FRIM TO PROPER LENGTH PAST THE BEND OF THE HOOK, ABOUT 3/16 OF AN INCH. GOOD LUCK.

HOOK: SCUD STRAIGHT EYE SIZE 12

HEAD: GOLD BEAD SIZE 1/8

BODY: EGG YARN; CHARTRUSE AND PINK

Stoneflies


The scientific name for this order of insects is *Plecoptera*, which in Latin means "braided wing." The wings of adults have numerous veins, making them appear braided. Stoneflies, as you can guess, live in habitats with plenty of stones. They prefer fast-moving, clear streams with a bottom of rocks and stones. Small mountain brooks and large streams in wooded areas usually have plenty of this type of habitat, and often many stoneflies.

Stoneflies, like mayflies, have incomplete metamorphosis. The stages of incomplete metamorphosis include egg, nymph and adult, or "ENA."

ADULT

The wings of adult stoneflies fold back flat over the body. Caddisflies also have "laid back" wings, but they almost form a tent over the body. After hatching, the adults fly to stream-side vegetation, where they may live from a few days to a few weeks. Many adults do not eat, but those that live as adults longer do eat vegetation, pollen or nectar.

The adults attract mates by "drumming"-bouncing up and down on their vegetation perches. They mate on this vegetation and the female takes the fertilized eggs to the water to deposit them. She may skate across the surface, dropping egg packets. This is often when trout eat the adults. A bushy dry fly skated across

POINT> and <COUNTERPOINT The Third of a Series:

Frequently Asked Questions Regarding the Chattooga Headwaters

Editor's note: A boater posted a link on the Sumter National Forest Bulletin Board to "Frequently Asked Questions." Here are the next 2.

Will opening the upper Chattooga to paddling allow tubers to navigate the Chattooga?

Boater's point: Not necessarily. Paddlers are requesting access for whitewater boating, which requires specific craft designed for the activity. Paddlers have never requested that craft not designed for whitewater be allowed on the Chattooga. Furthermore, the reaches are likely not desirable for floating in tubes.

Counterpoint: Although the boaters are not requesting access for tubing, tubing and similar activities are inevitable if the Chattooga's North Fork is opened to unlimited floating. Occasionally tubers are already "poaching" backcountry float trips from Lick Log Creek to Highway 28. Should boaters gain unrestricted access, both the 'experienced' and 'less skilled' floaters with their "specific crafts" could put-in at Burrell's Ford at any water level. During low water levels the view from the bridges at Burrell's Ford and Highway 28 is deceivingly placid to the 'less skilled' (a.k.a. Bubba) boaters. Some will probably be anglers with their open cockpit kayaks, canoes, personal pontoons, and float tubes. Is it possible to place restrictions on the level of experience required for boaters on the North Fork? If so, what government agency would be willing to assume the responsibility of judging the qualifications of persons participating in sports such as whitewater boating? It may be expected that no government agency would be willing or have the resources to conduct such evaluation, with the inevitable result that non-experienced boaters will try to float the North Fork, resulting in unnecessary rescues and injuries. The present North Fork zoning solves that dilemma.

Will opening the upper Chattooga to paddling allow commercial use?

Boater's point: No. Paddlers are requesting access for non-commercial use only. Commercial permits for use of public lands and waters are an entirely different matter. More importantly, the upper Chattooga will not support commercial use due to its flashy hydrology, stream size, and difficulty. Commercial outfitters have openly stated that they have no interest in rafting on these sections. There are thousands of whitewater streams on USFS lands, all of which are open to boating except the Chattooga, but commercial boating occurs on only a small fraction of those streams, when permission is granted.

Counterpoint: Yes, opening the upper Chattooga to paddling will open this area to commercial use. Although we agree that commercial guided rafting will not be authorized, there will be no limitation on the use of "taxies" and rental boats, which are certainly "commercial" uses. American Whitewater agrees that these are commercial uses when they wrote a letter about lower Chattooga boating to the USFS dated 6/10/02, explicitly acknowledging that commercial users are less skilled than non-commercial users. The following are excerpts from that letter, "Other commercial users - the shuttle clients and/or rental customers of any other special use permit holder such as a shuttle permit or any entity that advertises to rent equipment on the Chattooga River. In general this group of users are less skilled, less aware of their impacts on the river, and are more prone to needing public search and rescue services." "Shuttle permits are generally issued to the companies that also rent inflatable kayaks or other river craft and commercially promote and encourage river use." "There are no restrictions on the number of craft a company can rent." http://www.americanwhitewater.org/resources/repository/Final%20AW%20comments%20re%20Amendment%2014%20EA%20June%2010%202002.pdf

If the Agency were to grant the "unlimited use" that the private boaters are requesting, shuttle services and rental inflatable kayaks (a.k.a. duckies) would be permissible. Private boaters may use either "rental" or "owned" cars or boats. The Forest Service can't discriminate if a private boater uses rental equipment. For safety considerations, would <u>guided</u> duckies be permitted next? Then maybe "creeking" clinics? That would be kind of like "the camel's nose under the tent." The present zoning prevents this.

What's New in the Chattooga Zoning Issue?

Dec 15 (Fri) The USFS's Consultant notified (by E-mail) the members of the angler panel, due to the holidays, "we are now looking at January for our first field event, assuming that we get the appropriate flows."

Dec 21 (Thu) Boater's Court Case Update: As a result of the Notice of Appeal filed by the boaters, the 11th Circuit Court appointed a Case Mediator. On 12/21 the mediator conducted a "settlement" conference telephone call with the parties involved.

Obviously, however this issue is resolved it will be precedent setting with far reaching consequences into the future and across all federal agencies that manage and zone recreational waters. You need to share your views NOW.

Have you experienced user conflict or interference from whitewater boating on a mountain trout stream? Is it worse now than it was 20 years ago? What's it going to be like in another 20 years? Do we need more stream sections zoned like the North Fork of the Upper Chattooga, for "foot travel only"? If you have an opinion, please take a few minutes and tell the Forest Service.

What's New Elsewhere?

The USFS has eliminated formal environmental impact statements from the process for writing overall management Chattooga Conservancy, Engineering Management, Inc. (a plans that are required every 15 years for each of the 155 national forests. WASHINGTON, DC, (12/13/06) (ENS) The agency said that "writing management plans has no effect on the environment." This determination qualifies the individual plans of each national forest for "categorical exclusion from individual study" under the National Environmental Policy Act, NEPA. The forest plan revisions will now take two to three years instead of over five years with the previous rule, the agency said. The decision came after what the agency called "environmental review" of the new process for developing and updating land management plans under regulations published last year. Under the 2005 planning rule, full environmental analysis will continue at the project level, the Forest Service said. Embrace-A-Stream Grant Application Submitted by Rabun TU for Stekoa Creek Monitoring Project (12/14/06)

Amount Requested - \$6,000: Total Project Cost - \$41,063 Stekoa Creek is classified as primary trout water, and should be capable of supporting trout reproduction. Stekoa Creek is also infamous as a major, very polluted tributary to the National Wild & Scenic Chattooga River. Persistent lack of corrective actions by state and local authorities to address excessive fecal coliform and sediment levels has been responsible for the continued deterioration of the stream for over 30 years. Thus, Stekoa Creek is currently listed as an impaired waterway by state and federal agencies for not supporting its designated uses as a primary trout stream and recreational resource.

Overall Goal: The overall goal is to restore the water quality of Stekoa Creek to its designated uses as a primary trout stream and recreation resource, and to restore the National Wild & Scenic Chattooga River downstream of the Stekoa Creek confluence to the water quality standards that have been set for swimming and associated water contact sports.

Proposed Action Plan: Rabun Chapter will partner with the certified laboratory), and Georgia Wildlife Resources Division of GA DNR in the Conservancy's ongoing water testing program for identifying pollution sources in Stekoa Creek. This partnership will boost the program by allowing for an intensified sampling schedule of testing once a week at 8 sites along Stekoa and its suspect tributaries.

Stop I-3 Newsletter Update (12/1/06) For those of us concerned with protecting the quality of our environment and stopping Interstate 3, the results of November's election bodes well. Residents of the mountain region of Georgia and North Carolina sent a clear message to Washington, D.C. The people of Georgia's 12th Congressional District chose to re-elect Rep. John Barrow, who was running against former Congressman (and well known supporter of I-3) Max Burns. Voters in North Carolina's 11th District elected Heath Shuler over Rep. Charles Taylor. A major plank in Shuler's platform was his dedication to environmental protection. For example, he made it clear that he opposes construction of the infamous North Shore Road through the Great Smoky Mountains National Park. Instead, he sided with the Swain County Commission and the conservation community in support of a monetary settlement for the county. It seems likely that Representative-elect Shuler will oppose other proposals to build unnecessary, wasteful and environmentally damaging roads like I-3.
