GOLD RIB HARES EAR

THIS FLY WILL REPRESENT THE MARCH BROWN MAYFLY. POUNDING THE BOTTOM WITH THIS PATTERN CAN PROVIDE CONSTANCE ACTION FROM MID-MORNING INTO THE EARLY STAGES OF THE HATCH. HOWEVER NYMPAL COLOR TENDS TO ADAPT TO THE COLOR OF THE STREAM BED. DURING FEBUARY, MARCH AND EARLY APRIL HAVE SOME OF THESE TIED UP FROM A LIGHT BROWN TO ALMOST BLACK. I CAUGHT 30 + WITH THIS FLY THE 14TH of DECEMBER 2007 IN THE BACKCOUNTRY OF THE RIVER.

HOOK: 12 to 14 STANDARD NYMPH HOOK TAIL: DEER HAIR OR SQUIRREL TAIL BODY: RABBIT DUBBING COLOR OF CHOICE ABDOMEN: SAME AS BODY OR SHADE DARKER WING CASE: TURKEY TAIL


Tom Landreth

Tom joined Trout Unlimited in 1984 and became a charter member of the Rabun Chapter in 1986. For twelve years Tom served as newsletter editor. In addition he served as Chapter President (1995 & 1996), chapter secretary for three years and as a director of the chapter for four years.

Tom was a well-known and accomplished watercolor artist and fly fisherman who loved painting the area streams. He donated countless paintings to TU fundraisers over the years.

D**oug** An Angler's Tribute to Tom Landreth

The following is not "shop newsletter" material, but rather some personal thoughts I want to share with you. Jimmy Harris

In this season of love, giving and receiving, I want to ask each and every one of you to take time to reflect on the place each of these words occupy in your life. As we have all heard, there is a season for all things and that is certainly true for these: love, giving, receiving. Our challenge is to make the most of these seasons in our lives and, hopefully, cultivate them to where they become an integral part of who we are. Some of you may be blessed to the point that the mere mention of your name invites images of these traits. Would that we may all be this fortunate.

Yesterday, Saturday the 8th of December, I attended one of the most amazing events of love, giving and receiving that I have ever witnessed. What had begun as a luncheon among friends to express their appreciation to Tom Landreth grew into something no one had expected. Tom was battling cancer again and this time it was back with no regard for the doctors or their treatments. It was doing its best to dim the light that had beamed so brightly over north Georgia trout fishing and the art community. The luncheon had been planned for several weeks and was anticipated with both joyfulness and a heavy sense of melancholy. We all wanted one more opportunity to look into those smiling eyes and tell Tom how much he has meant to us as a friend, as a leader, as a man.

Driving up to Dillard I got a phone call telling me that Tom was too ill to attend the gathering. Okay, I thought, we're going to be there anyway, so we'll do some reminiscing, sign a card for Tom, maybe record a big Rabun "Waa-Hooo!" that can be played back for him at home and collectively send him our prayers. As I pulled into the parking lot in front of the Dillard House banquet room, it became clear that this was going to be more, much more. A steady stream of folks was already pouring into the room and one of the first faces I saw was Tom's brother Walt. With his typical huge grin, Walt greeted me and thanked me for coming. "I wouldn't have missed it" I replied with sincerity. Working my way around the room I heard someone say that June was there along with their daughters. Wow! What strength she has to be here. It must be difficult to look at all the video images on the screens of a healthy Tom. What strength she has, when Charlie's voice cracked as he tried to open the luncheon with a prayer, to announce to the room that this was a celebration of Tom's life. And the strength to gracefully hold the hands and look into the eyes of every person who approached to tell her how much she and Tom are loved.

Over 200 people made the trip to Dillard yesterday to tell Tom how grateful they were that somehow they had been chosen to share some of life's experiences with him. Two hundred people who had in probably two hundred different ways been touched by Tom's loving and giving. Now it was time for Tom to receive. To receive the genuine emotions of gratitude and respect for his life. While there were certainly tears shed throughout the day, it was indeed a celebration of Tom's life and I am blessed to have been there with all the others, each with their own Tom Landreth story.

My own "Tom" story is a simple one of being the recipient of his giving personality. In the mid-70's I had decided I wanted to learn how to flyfish. Living on the banks of the Arkansas River in Russellville, Arkansas at the time afforded me plenty of opportunities to practice my skills on bream, bass and even a catfish one time. With no tutoring other than a book I checked out of the Arkansas Tech University library, I actually became a somewhat decent caster and a terror on the neighborhood began to pursue the wily trout with my flyrod. I must admit, I looked good up on the Chattooga River as I aerialized that fly line and cast only to rising trout. It wasn't that I was being snobbish, I just didn't know that you could catch them with anything but a dry fly. For two seasons (two years!) I kept traveling to the Chattooga and the upper Chattahoochee Rivers to flyfish for trout, and I never hooked a fish. Never! One day I happened to read a small announcement in the Tri-County Advertiser inviting anyone interested in trout fishing to a meeting of Trout Unlimited. A phone number was listed at the end of the announcement so I called to find out more. The phone number belonged to Tom and, like a sinner at confession, I began to tell him of my pitiful attempts to learn how to flyfish for trout. If the thought ever crossed his mind that he was on the phone with a nut, he never let on. In fact, he invited me out to his home without ever having met me. That was my introduction to Rabun TU and a group of folks who took me under their wings and literally taught me how to catch a trout on a flyrod. It was intimidating at first but the desire to learn was so strong within me that my fears took a backseat. I have told Tom's family that he is the reason I am where I am today. Now, he may not have wanted to take credit for that but in my mind it's a fact and I will forever be indebted to him as are so many others.

At 11:57 PM last night (December 8th), Tom Landreth passed away. How ironic is life that it would occur on the same day as our gathering to show him our appreciation. Tom was not there in person but his spirit filled not only that banquet hall but the hearts of everyone in there. It is only fitting that those of us whose lives have been impacted by Tom (and you are one if you trout fish in Georgia regardless of whether you knew him personally or not) will make a more concerted effort to love more and to give more. Reach out to someone else, even if you think they may be a nut, and teach them some of what you know. Help them to see the beauty of our sport and the natural resources we have been blessed with in which to enjoy it. Help them to understand the work that has gone on before them by people like Tom to insure they had this opportunity today and will tomorrow if they'll only take up the torch and move forward with it. Tom Landreth helped set the standard and for that we are grateful. And in his memory we will try to uphold that standard.

FISHING REPORT

Sent: Wednesday, November 28, 2007

Here's another fishing report from a couple of flatlanders. The picture is of Kevin's first Steelhead that he is holding while proudly wearing his Georgia Trout Camp vest.

While visiting family in Pittsburgh over Thanksgiving, I planned a Steelhead trip to the Erie area to fish Elk Creek with my brother-in-law Scott Davidson and my son Kevin. We headed north Wednesday morning at 5:30 am and got on the water at around 8:00. It was a great day for November fishing, overcast with a slight breeze and 65 degrees. As soon as we stepped into the creek Kevin couldn't wait and began casting. After about 5 casts, he had one on, but then lost it after a pretty impressive tail walk. I turned around and Scott had his line in and was working a run. After much pleading, I convinced them both that we'd be better off moving upstream and away from the parking area which could get many other fishermen plodding past us to get to other fishing spots. I have a favorite spot on Elk Creek and we made a beeline for and when we reached it, Kevin, Scott, and I spread out and I had a fish on immediately. I brought my large catch and release net with me on this trip, and by large, I mean it is well suited for big 18"-20" trout you can catch on the Soque or Nacoochee Bend. When Scott grabbed the net to land my fish, only half of the fish would fit in, and it kept jumping out. I took this as a good sign. Kevin soon had one on and it was a big one. It made at least 5 runs before tiring out and letting me get close enough to it to land. The net was a joke and I ended up just using it as a barrier to keep the fish from flopping back into the water. Kevin's first Steelhead was a beauty and was easily over 8 pounds and measured 27 inches, 3 inches longer than the net including the handle! We fished for a total of about four hours and Kevin ended up with 4, Scott had 3 and I finished the day with 4. We each had on at least a dozen more, and all in

all it was a fantastic day on the water. The smallest fish caught was 20" and Kevin's fish ended up being the big fish of the trip. Thanks, **From:** Dave Lash –




Stekoa Creek Update

Stekoa Creek Monitoring - A National Trout Unlimited "Embrace-A-Stream" Project <u>HERE</u> Stekoa Creek is classified as primary trout water, and should be capable of supporting trout reproduction. Stekoa Creek is also infamous as a major, very polluted tributary to the National Wild & Scenic Chattooga River. The City of Clayton is entirely in the Stekoa Creek watershed.

DRIVING FOR TROUT

Seventeen (18) members of Rabun TU have volunteered their time and vehicle expenses to drive the weekly Stekoa Creek Monitoring water samples to the certified lab in Jefferson, GA (132 mile round trip) on Tuesday mornings at 10:30 AM.


I want to thank each of you with Trout Unlimited for the value you place upon clean water in Rabun County. Through water testing that has been funded by Trout Unlimited the Chattooga Conservancy has notified us of many high fecal coli form counts. That in turn has allowed us to go to that area, discover the source of contaminants, and repair it. To my knowledge this has allowed the City of Clayton to repair many leaks that were infiltrating either Scotts or Stekoa Creeks.

Again thank for your aid to this situation and I can only ask that this program be continued to allow continual improvement of the collection system.

USFS - GA: Forest Service Considers Land Exchange; Will Benefit County and National Forest, Officials State The following are excerpts from a News Release; Clayton, Georgia (12/3/2007) Dave Jensen, District Ranger for the U.S. Forest Service, announced today that the Forest Service is considering a proposal for a multi-party land exchange that will involve land in Rabun, White, Putnam, Murray, and Jasper Counties. Parties in this proposed exchange include the Rabun County Board of Commissioners, the Rabun County Board of Education, private citizen Mr. Larry Cooper and the U.S. Forest Service. Within this particular proposal, the United States of America would convey approximately 323 acres of land to the exchange proponents and would receive approximately 759 acres of land as part of the

Insights into Anglers - Excerpts from the 2007 Survey Summary

AnglerSurvey.com monitors angler's monthly outdoor activities, purchases and opinions. These surveys have become an important tool in helping the American Sportfishing Association, industry, media, and fishery managers understand the trends affecting participation and sales. The following excerpts are some highlights from the 2007 surveys:

What Motivates People to Fish? (March, 2007): There are many reasons why people fish, according to polls. Experiencing nature, relaxation, and spending time with family and friends are the top reasons for getting outdoors. "Most anglers go outdoors for more than one reason," explains Rob Southwick, who oversees the monthly surveys. The true benefits from time spent outdoors are to unwind, experience nature and to reconnect with others. The results reinforce similar findings from other recent scientific studies."

Most Anglers Release Fish They Catch (January 2007): Most anglers choose to release most of the fish they catch. According the a January 2007 poll by AnglerSurvey.com, 60% of anglers said they release most of the fish they catch, while 18% responded they release all the fish they catch. Only 21% keep most or all of their catch.

Where Do Fishing License Revenues Go? (April, 2007): Only 39 percent of anglers knew the correct answer: 100% of all license dollars go to the state fish and wildlife agency. Sixty-eight percent of anglers believe some or all license dollars go into the general state treasury. All states dedicate 100% of their license revenues to fish and wildlife management. Failure to so will cause a state to lose its share of federal excise tax dollars generated from the sale of fishing and hunting equipment and motorboat fuels. In 2007, nearly \$350 million in fishing excise tax dollars and \$267 million in hunting excise taxes were distributed to state fish and wildlife agencies to benefit sportsmen and conservation.

Who Do Anglers Trust the Most for Accurate Information on Fish and Wildlife Issues? (April, 2007): Where do anglers prefer for accurate information? The April 2007 poll shows 42% of anglers prefer state fish and wildlife agencies for accurate conservation-related information followed by 19% who prefer magazines.

Global Warming is a Concern for Most Anglers (June, 2007): Most anglers are concerned about global warming. In June, 2007, 66% of anglers reported they consider global warming to be a threat. Of these, two-thirds think global warming is a natural cycle that is accelerating as a result of human activities. At the other end, 16 percent of anglers felt global warming was not an issue but is being made into an issue by others.

Anglers are Concerned about the Issues (October, 2007): Anglers were asked in a poll by AnglerSurvey.com if they consider themselves knowledgeable regarding current state and federal issues affecting the quality of fishing. Of the 1,148

anglers who responded, 48% indicated they keep an eye on the issues and focus on those that affect them directly. 25% of anglers said they watch the issues closely and 22% said they do not follow the issues as close as they would like.

How Will Increasing Gasoline Prices Impact Anglers This Year? (June, 2007): Gas prices are impacting fishing. Over half of all anglers indicated rising gas prices will cause them to reduce their outdoor activities or reduce their travel distance and boat use in 2007. The rest indicated that rising fuel prices would not hinder their outdoor activity, or were not sure of the impacts.

Anglers are Split on Whether Our Nation's Energy Needs Outweigh the Potential Environmental Impacts that May Occur (March, 2007): Many people wonder if our nation's energy needs outweigh potential environmental damage that might occur if the U.S. drills for oil in Alaska's Arctic National Wildlife Refuge. According to AnglerSurvey.com, anglers are split over this issue. Almost half either strongly or somewhat agreed that our energy needs outweigh the environmental risks (46%), while half (48%) felt the environmental dangers are greater. The remaining were undecided or had no opinion.

Friends are the Best Source for Product Information (February, 2007): When seeking information about which products to buy, recommendations from friends were reported as having the greatest influence (40% of anglers). Endorsements by personalities and television commercials have the least effect with 5% or less of respondents favoring each of these sources.

More Anglers Use Magazines as Their Fishing Source (June, 2007): Anglers use magazines as their top source to learn more about fishing and for fishing entertainment. According to a June, 2007 poll by AnglerSurvey.com, 43% of anglers reported magazines as their top sources and 24% replied websites. Television was selected by 19% of anglers and 9% use the newspaper.

Most Anglers Use Spinning and Casting Tackle When Fishing (July, 2007): Most anglers (53%) only use spinning, spin cast and bait casting gear. Thirty-one percent use spin / casting tackle most of the time and fly fishing gear some times. Only 1% said they fly fish only while less than 6% mostly fly fish and use conventional fishing tackle some of the time. The remainder reported using other types of fishing tackle.

"The agency is working diligently to prepare the EA for public review," said Sumter National Forest Supervisor Jerome Thomas. "As anyone familiar with this subject knows, the issues being considered in this EA are wide-ranging and complex; we need additional time to complete our analysis."

Excerpts from "The Evolution of a Fly Fisher" by Joan Salvato Wulff The early stages are familiar to most anglers: the focus is on 1) the numbers. How many did you get? 2) The biggest fish. How the numbers was also be a photo. And then the most difficult: (3) the wise old brown trout instead of the eternally innocent brookies: After Stage 3 the scope broadens; we enter the stages that are about more than catching fish. Stage 4: give something back to the resource. It is about preserving the gene pool as well as their habitat. The national conservation organizations are there to lead the way: the Federation of Fly Fishers, Trout Unlimited, the Atlantic Salmon Federation, the International Game Fish Association. The golden years: Stage 5. *Just being there*. In these years, *catching* fish has become less important; I can be fishless and still have a good day. I can now fish "through" a companion and be as happy about their catch as they are because I know the challenges, and feelings of joy and satisfaction, that commemorate success. I have one more stage to include in golden years: #6. Replace yourself. This is about bringing young people into our sport. Unless we do this, our sport will be diminished: first in number of anglers and then, with fewer anglers working to preserve the habitat, in quality.
