From the Desk of Chris Wood

Last week at his kindergarten's celebration of Black History month, my son Wylie stood up and said, "My name is Lloyd Hall. I am a food chemist. I discovered a salt mixture that helps food last longer." While I was getting over the disappointment that he didn't get to "be" Jackie Robinson, Ethan grabbed my arm and said, "When are you going to take us fishing again?"

The "fishing" that Wylie's friend referred to involved TU staff Dave Rogers, Andy Snyder, and Keith Curley reading books, tying flies, and casting in the school's playground. We'd planned a legitimate fishing day but Wylie's teacher, and I'm not kidding, left one of the kids at the library the week before. After that, the principal "rescheduled" our outing to the school grounds.

Kids today are far more likely to spend time on a computer or in front of the idiot-box (as my Mom calls the TV) then they are to wander creeks. In a single generation, we've moved from a society where 60 percent of us grew up in rural areas to one where 80 percent now live in urban or suburban places. Childhood obesity is on the rise as kids spend less time outdoors, and not surprisingly, the number of licensed anglers in the U.S. has declined.

This is where TU fits in. Recovering wild and native fisheries so that our kids can fish for them in their home waters requires protecting the highest quality habitats and reconnecting them to lower elevation areas through local restoration activities. TU developed the **Stream Explorers** program (www.streamexplorers.org) so that future generations ensure that such vital work endures.

Membership in Stream Explorers gets you a neat quarterly newsletter with activities kids can do on their own or with parents and teachers. It costs \$12 a year. I've signed up my kids, and my brothers' families as Stream Explorers. I hope you'll do the same.

Stream Explorers, Trout in the Classroom, and youth camps demonstrate to our children that we are optimistic about a better future. Every time we take a kid fishing, or on a stream clean-up, or teach them how to plant trees, we reaffirm the promise of TU's vision. And that's not just good for TU, it's good for the country. Thanks for all you do. Stay in touch.

Stekoa Creek Update

Stekoa Creek Monitoring - A National Trout Unlimited "Embrace-A-Stream" Project in 2007 & 2008 HERE Stekoa Creek is classified as primary trout water, and should be capable of supporting trout reproduction. Stekoa Creek is also infamous as a very polluted tributary to the National Wild & Scenic Chattooga River. The City of Clayton is entirely in the Stekoa Creek watershed.

DRIVING FOR TROUT

Eighteen (18) members of Rabun TU are volunteering their time and vehicle expenses to drive the weekly Stekoa Creek Monitoring water samples to the certified lab in Jefferson, GA (132 mile round trip). The samples are collected weekly by trained employees of the Chattooga Conservancy and transferred (by a chain-of-custody procedure) to a TU volunteer.

Subject: Stekoa Creek Task Force - meeting delay

Hello everyone.

During our last meeting in October, we had agreed that the next Stekoa Creek Watershed Task Force meeting would be scheduled for January. Since our last meeting, here at EPA we have been undergoing some changes. The Water Management Division, has been undergoing a reorganization these last couple of months to include a new name, Water Protection Division, and changes to the Branches and Sections. One of these changes was that the Watershed Management Office, within which I worked, was dissolved and staff from this office were moved into different sections, including a new Watershed Coordination Section, which is located in the Water Quality Planning Branch. The Watershed Coordination Section consists of a watershed coordinator for each of the eight states in

As part of this reorganization, I accepted a reassignment to the Clean Water Enforcement Branch. The reorganization and my subsequent reassignment are why you have not heard from me these last few months. Mary Jo Bragan has recently accepted the Georgia Watershed Coordinator position. You may have met Mary Jo during some of our earlier meetings. Right now Mary Jo and I are working together to ensure a smooth transition here at EPA as we begin the planning process for FY2010.

I think it's important for the Task Force to meet, especially to talk about the work the Fix the Sewer Group has been involved in (and potential opportunity to receive money from the stimulus package); update on the 319 funding; and the draft Outreach Plan that Larry Walker put together. However, because of changes occurring here, I think it's going to be April before someone from EPA will be able to coordinate a meeting.

I wanted to see if there is someone who would be willing to coordinate the next meeting or coordinate sharing information with the group through email. I think everyone has been doing a great job to keep things moving forward and wanted to thank you for your efforts in this process.

Cissy Henry, on her own volition, worked tirelessly evaluating and compiling the pertinent information, completed the required government forms and submitted them in enough time to have already received a promising phone call back from Atlanta. Hurray Cissy!

Most likely the John English Drive sewer replacement will be the most favored candidate. It's our biggest project, it will create the most jobs and it will help the greatest number of people, making it our best shot at getting a really big chunk of the pork.

My concern is this: to actually get money in hand, Obama requires the project be shovel ready. This project is shovel ready, except we still lack a few property easements. With these easements and the stimulus money, we could finally get this long-awaited sewer project finished, improve the quality of life for those folks granting the easements, and increasing property values for the entire neighborhood.

It would also free up the \$207,000 earmarked for this sewer project to be applied towards other sewer projects or replacing old water lines. It's within our reach and I'm excited thinking of the possibilities.

The letter should be short and contain:

- 1. Disappointment at the performance of the Senators/ Congressman
- 2. Demand that they follow-up the requests and send letters to the conference committee, requesting \$ for the 2010
- 3. Suggest that they work with Jack Kingston, who is on the appropriation committee to fund these projects.
- 4. Discuss the importance of these projects in protecting Georgia water quality in the headwaters of major rivers.
- 5. Tell these people that they are killing a popular program and hurting conservation efforts in our State.

USFS-NC: TU Applauds Forest Service Tellico Decision

TU applauds the decision by the U.S. Forest Service to protect critical brook trout habitat in North Carolina's Upper Tellico Off-Highway Vehicle (OHV) trail system by recommending as its preferred alternative the closing of a 39-mile OHV trail system in the Nantahala National Forest. The area is located in the Tusquitee Ranger District, in Cherokee County, North Carolina.»Press Release

Public Land Nationwide: Omnibus Public Land Management Act of 2009 fails in House Washington, DC. On 3/11, the House of Representatives voted "for" 282-144 and failed to achieve the twothirds majority needed to pass. The vote was conducted under the suspension of House rules, which is why the two-thirds majority was needed to pass it. On 3/20 the Senate passed 77-20 this package of legislation related to public lands, national parks and water development. It will now be sent back to the House for consideration in the immediate future. The package includes *The Chattahoochee* Trace National Heritage Corridor Study Act of 2007 (S. 637), would direct the Secretary of the Interior to study the suitability and feasibility of establishing the Chattahoochee Trace National Heritage Corridor in AL and GA and The Wyoming Range Legacy Act (S. 2229), would protect 1.2 million acres in Wyoming's Bridger-Teton National Forest from new oil and gas leasing. The legislation has been crafted to allow for existing energy development to continue by way of directional drilling into the Wyoming Range, minimizing impacts to wildlife habitat and the Grey's River watershed. Fishing Dukes Creek by John Springer (2/21/2009)

A wonderful area to fish in late fall or very early springtime is in NC, SC and GA. The weather from what I have experienced in 6 trips can be very cold at night but during the day as a rule the temperature goes up to the high 50's and low 60's. As always there are days this does not happen, and it stays cold. Just put another piece of shot on your leader and fish a bit slower.

This past trip I fished a small river in Georgia called Dukes Creek, it's located in the northeastern top part of the state near the town of Helen. This area is called Smithgall Woods there is a bit of history about the area. It was mined and logged until nothing was left. Then a gentleman who knew the value of this piece of land started buying it up. When he was done it was said to be worth 21 million dollars. He sold it to the state for half price as long as it was kept and operated as a wildlife area forever for everyone to enjoy. The creek can only be fished 3 days a week by a maximum of 15 anglers. You call them up and they give you a reservation in advance.

When I went they were having a bear hunt on the property so I could only fish the first mile of the 4 miles of river they control. It was not a problem as there were only 4 of us fishing this day. Our only problem was it was 22 degrees the night before and the river is completely enclosed by a canopy of trees, so it never really warmed up.

They have been in a serious drought for a long time so because of the low water conditions the fish were only in the deepest pools. There are many trophy size fish to catch, the water is gin clear and as with any C&R water a real challenge to catch. I saw many 14-16 inch fish; I caught a 10-inch rainbow. Had the water been a bit warmer and the fish feeding I might have done a bit better.

Like the others I have fished there, this stream has a sand bottom with good size rocks - no gravel and no mud. From what I have been told the hatches are not all that good but they have caddis and midges with some Mayflies.

There are picnic tables spread out and pavilions to sit and eat. All the major pools also have beautiful wooden staircases to bring you to the river so that the banks are not trampled. For public water I have never seen a place so well kept up.

In Helen there is Unicoi Outfitters fly shop. Il you're on a family vacation the town of Helen was built to look like a Swiss village, from what I saw there are enough stores to go through to keep any women shopping for several days while you fish.

If you're down that way and want to fish in a beautiful place, very wild and scenic looking spend a few days on Dukes Creek. Oh yes one more thing, there is no charge for fishing this almost private water. All you need is a license. They do sell local honey and they have a jar for donations. You should leave them something to help keep the place going. It is much appreciated and well worth it.

Currently anglers contribute \$1,500/year to deliver GA WRD's trout to the lower backcountry sections of the Wild & Scenic Chattooga's North Fork and West Fork. The helicopter trout stocking, which began in 1971, is part of an annual fisheries management "put & grow" program to supplement the natural trout reproduction in the lower sections with sub-adults (approximately 5 inches long). There is no stocking above Burrell's Ford where the trout fishery is sustained by natural reproduction of brown trout.

Tom Landreth, a charter member of Rabun TU, died in December 2007. Tom was a well-known and accomplished watercolor artist and fly fisherman who loved painting area Knowing of Tom's love of trout fishing and the Chattooga backcountry; his family gave their permission to establish the Tom Landreth Memorial Fund at Rabun TU with all donations used to help pay for the Chattooga backcountry helicopter stocking program. Subjects discussed included data base for Back-the-Brookie (BtB), 2009 BtB plans, background and current status of the summer intern program, importance of USFS Wildlife Technicians, partnering with USFS & GA WRD for wild trout enhancement projects, the December annual planning meeting, schedule of current in-stream projects with TU Chapters HERE, the Chattooga Coalition, protection of large woody debris in streams, backcountry helicopter stockings, kids fishing events, GA Trout Camp, etc.

Mar 17 (Tues Evening) Chapter Meeting - 26 Rabunites attended Program: John Cross is manager of Unicoi Outfitters and a professional trout guide. He presented a very informative program full of tips for fly-fishing in North Georgia trout streams. John says to fish with at least 2 flies, an attractor and a trailer. Fish deep with a woolly bugger and trail a small nymph. Fish mid depth with a floating fly such as a stimulator trailed by a weighted nymph at varied dropper lengths, fish near the surface with a floating fly such as caddis and trail an unweighted nymph or soft hackle, fish on the surface with 2 dry flies that match the hatch, fish a midge trailing behind a 14 or 16 parachute or humpy. Change the trailer fly pattern often. Use fluorocarbon tippet below the surface and nylon on the surface. Add and remove sinkers to vary depth to get to the location of the holding trout. Vary the length of the trailing tippet. Stalk wild trout. With a good presentation, wild trout have 2 choices – eat or starve. Hook sets are FREE (there is no charge at the end of the day for hook sets). Great program – thanks John. Meeting raffle had 9 buckets with a 16 caddis fly selection, a jar of local sourwood honey, a 36 piece screwdriver set, a waterproof fly box from the Tom Landreth estate, a snake bite kit and much more. The raffle raised \$115 to be used toward the cost of mailing newsletters to members without E-mail and for the meeting hospitality expenses. A BIG "thank you" goes to all the Rabunites who donated the items and to the members who purchased raffle tickets.
