## ORW UPDATE FOR CHATTOOGA RIVER BASIN

1) Outstanding Resource Water status for the Chattooga Basin is now being evaluated by the N. C. Dept. of Environmental Management. 2) We will know by mid-March if the state will hold public hearings.

#### BIG CREEK SITUATION

A Permit has been issued for the NPDES discharge into Big Creek; <u>but</u>, "authorization to construct" has been placed on "hold". pending ORW classification for the Chattooga River Basin.

#### CHATTOOGA RIVER JETPORT

Well now trout fisherman, how does this sound to you? A 5000 foot runway airport for light conventional and jet aircraft located on a ridge just outside the Wild and Scenic River Corridor near US 76 and the Chattooga River. At this time nothing is finalized but the USFS has given permission to the Rabun County officials to study the site. Presumedly, there will be room for many other support services for all those wishing to experience the wilderness.

## TROUT UNLIMITED AND THE UNITED STATES FOREST SERVICE

A Memorandum of Understanding was signed on December 4, 1987, between TU and the USFS. The agreement encourages the development of joint trout and salmon habitat improvement projects in our nation's national forests. The USFS manages <u>128,000 miles of stream</u> plus 2.2 million acres of lakes and reservoirs as well as 16,500 miles of coastline - <u>50% of the</u> trout and salmon habitat in the United States.

TU leaders are already meeting, or have met, with USFS officials planning site specific projects.
