Fred Young of DNR's Real Estate Unit updated the Board on the status of Preservation 2000. He reported that his unit is negotiating with twelve property owners for the purchase of 53,000 acres of land. The DNR Board will be asked to approve the acquisitions after they are announced by Governor Miller.

The May 27 meeting of the Board was also held outside of Atlanta, at Madison, Georgia. At the May meeting, DNR Commissioner Tanner reported to the Board that with the end of FY 92 approaching, the State's Office of Planning and Budget has requested that each agency lapse one percent of its current operating budget to address the concern that the Administration's revenue estimate might not be met. This amounts to between \$550,000 and \$650,000 for the Department of Natural Resources.




"Making A Difference In Georgia"

Georgia Council of Trout Unlimited Goals for 1992

- Continue our cooperation with U.S. Forest Service to improve trout habitat on streams inside Forest Service boundaries
- II. Continue to build on our relationship with Georgia Game & Fish.
- III. Seek out private property owners that will cooperate with Trout Unlimited, in trout habitat improvement and bank stabilization projects.
- Become more involved in water quality monitoring and enforcement in the North Georgia Mountains and the lower Chattahoochee River.
- Continue educating the public for the need to conserve and protect our cold water resources.
- VI. Become more involved in educating our school children about cold-water fisheries and Trout Unlimited's conservation role.
- VII. Make recommendations to Site Selection Committee for Preservation 2000.
- VIII. Become more involved with Conservation & Environmental groups in Georgia and share information that can help our cause.
- IX. Work on ways to increase membership in the state, and spawn new chapters.
- X. Work for a year around trout season in Georgia.
- Work for lower creel limits on select streams in Georgia, and maybe even a XI. Catch-And-Release only area.
- XII. Work with Forest Service and Game & Fish on Brook Trout restoration project, both monetarily and with volunteer labor.
