### **Tight Lines**

On the weekend of September the 9th, the weekend after Labor Day, the U.S Forest Service, The Rabun Co. Chapter T.U., The Chattooga Chapter of T.U. (S.C.), and our Foothills Chapter will be participating in a much needed project on the lower part of Reed Creek at the confluence of the Chattooga River. This project is being planned as a camp out, social, partial work day and fishing trip all "rolled up" in one weekend outing.

I will describe the work first. Since it is always the most undesired. The project area will be in the flood plain of lower Reed Creek where Reed flows into the Chattooga River. It will be from the river up stream for approximately 400 yds. We have planned on building three large Single Wing Constrictors 33' long with three 33' Cover Logs across from the constrictors. These structures are designed to improve the habiat for trout by creating long deep fast flowing pools. This type of habitat is much needed in tribs of the Chattooga River such as Reed Creek, because of fish moving out of the river during hot summer days seeking cooler water. We believe that tribs such as Reed can be "life savers" for trout during days of higher river water temps such as 70+ degrees F.

The logs for these structures have already been cut, measured and "snaked" into the creek channel by a team of two Belgium horses and owner "Snuffy" Richard Hall from S.C. They are at the locations they need to be for installation. All we need now is to have at least 6-10 members from each 3 chapters to come out on Sat. Sept. 9th and help build these from about 9 a.m. until 4 p.m. and then go fishing if so desired. I am desperatley asking for your help in getting these completed. We hope to have each chapter building a Constrictor and a Cover Log across from it. So please try to come and work for part of that day. The rewards will be very benefical by enhancing this habitat.

Second, camping on the Chattooga near the project site will be taking place starting on Friday afternoon the 8th of Sept. We will have an area set up for TENT CAMPING. A pull camper will never make in on the access road coming in. The road is an old road that follows up the side of the river to some Wildlife Openings where the camp will be located. Most any vehicle should make it in but I suggest not to bring your BMW'S or Cadillacs. The road has one small Spring Branch ford and a few small mud holes, but 2 wheel drives should make it fine. The distance from highway 28 is approx. 1 mile in to camp.

The Rabun Chapter usually has someone who "picks and sings" and tells some good fishing tales. These guys are always good for a great camp and fun "social" on Friday night before the work day on Saturday. You are welcome to bring any kind of beverage of your choice. So please, put it on your calendar and come on out and do a little work and have some fun camping and fishing on the "Mighty Chattooga" it is a beautiful place!!! Directions follow on map. Time schedules are: Fri. Sept. 8th camps can be set from 1 P.M. on. Gate will be open....Sat. Sept. 9th work on structures from 9 a.m. until 4 p.m. Fish, relax, camp, or break camp after 4. Gate will be closed Sunday afternoon about 5 if anyone stays until then.

Directions to Russell Fields

From Georgia and North Carolina: Travel south on Hwy. 28 (towards Walhalla). There is an unnumbered Forest Service Rd. that will be on the left just before the Hwy. 28 bridge. It is usually gated but will be opened early Friday afternoon. If you cross the Hwy. 28 bridge, you have gone to far. When you get close, slow down! If you are unfamiliar with the turn it will sneak up on you.

From SC: T ravel north on Hwy. 28. After crossing the Hwy. 28 bridge and the Georgia line, turn on the first gravel road to the right. It is an unnumbered Forest Service Rd.

## James Payne Affected By Whirling Disease

I think I have whirling disease! After attending all of the activities of my three children (T-Ball, Softball, Soccer, piano recitals band concerts, dance recitals, church and school activities) all I seem to do is go around in circles. I do not know when I first became infected, but I do remember having the first "twitch" when I said "I DO." After the first child I began wailing to one side but could generally maintain a straight course. The second child made it difficult to get from point A to point B without turning around at least once. The third child put me in a tail spin. I understand the disease is now becoming prevalent in the wild populations of middle class males. Whole age classes (35 to 45) of the wild middle class males are now absent from trout streams. Biologist tell us that their research indicated these afflicted

Fly Of The Month From The Tying Table of the Bird Dog

Rio Grande King Trude

Hook: Dai-Riki Model 700C, size 12, 14, & 10.

Tail: Gölden Pheasant Tippet Body: Black Chenille Wing: White calf tail hair Hackle: Brown Rooster

This fly was used with great success on brook trout streams west of Hiawassee. Personally, I like to tie mine on a nymph hook so it can have the extra length. It also works great as a great indicator when fished with a nymph as a trailer. It floats like a cork and the white wings are easy to see. It is also very durable.
