# **Change In The March Fishing Outing Location**

The Foothills Chapter Banquet is on March 15th instead of the previous published date of March 22nd when the Rabun Chapter had planned to fish the Hooch and go to the banquet.

The fishing outing will be on the 22nd, but we will go to the Talluah River instead. Details at the March 18th meeting - be there.

There was a tremendous amout of discussion at the last meeting about the proposed 'wilderness' designation for the Rocky Gorge Section of the Chattooga River. The following was written by Art Shick who is the present Chairman of the SC Council of Trout Unlimited. The following snynopsis includes the reasons why this designation is opposed by the Chattooga River Coalition of which the Rabun Chapter is a member (the Rabun Chapter was represented at this meeting). This group is not to be confused with the Chattooga River Watershed Coalition which is another group that has their own agenda. I thought this issuance answered some of the questions raised at our last meeting. Ed.

The following issues concern our **Chattooga River**, thus it is imperative that we let our voices be heard. There are proposals for the **CHANGE** of designation on the **Rocky Gorge section of the Chattooga River**. The proposals call for the designation of "wilderness" to the Rocky Gorge area and the **opening up of the Bullpen**, **Burrell's Ford bridge to Highway 28 to whitewater canoeists and kayakers**.

All representatives at the Chattooga River Coalition (The Coalition is made up of representatives of the following organizations: US Forest Service from GA, SC, and NC, SC DNR, GA DNR, NC WRC and Trout Unlimited from SC, lowing organizations: US Forest Service from GA, SC, and NC, SC DNR, GA DNR, NC WRC and Trout Unlimited from SC, GA and NC.) meeting of January 17, 1997 approved the issuance of the following reasons for the opposition of the "Wildemess" proposals.

- The "Wild River" classification is more that adequate to protect the river and to provide a true wilderness experience for the occasional visitor.
- 2. The proposed "Wildemess" designation will be like a magnet, attracting large numbers of visitors. This results in over use and destroys the wilderness experience. The Ellicott Rock Scenic area, when designated a "Wildemess" in 1975, soon became the most visited "Wilderness" (visitors per acre per year) in the entire USDA Forest Service nationwide.
- 3. The proposed "Wilderness" designation will result in funding requirements for additional trails, trail heads, parking lots, signage, maps, management plans, etc. These are unnecessary expenditures in the present climate of fiscal constraints.
- 4. The studies, samplings and surveys conducted by the Coalition during the past decade have proven that the trout fishery in the river below Big Bend Falls has little of no natural reproduction and is completely dependent on stocking. The proposed Wilderness" designation precludes the stocking of fish (as it did in the Ellicott Rock Wilderness). This area of the Chattooga River has received annual stocking of trout for over 50 years. Prior to the "Wild River" designation, the river immediately above and below the Rock Gorge received heavy stocking of adult and fingerling trout by trucks. With the "Wild River" designation, the roads were closed inside—the comidor and light spring stocking of adult trout were made using helicopters. However, the dropsites were well upstream and downstream of the gorge. The trout fishery in the Rock Gorge was very poor during this period. For the past ten (10) years, the intense fall helicopter stocking of "put and grow" sub-adult trout has—restored and maintained an excellent wilderness trout fishing experience in the Chattooga River between Reed Creek and Burrell's Ford. The Trout are provided by SC DNR and GA DNR. The cost of the helicopter is paid 25% by SC USFS, 25% by GA USFS and 50% by Trout Unlimited.
- 5. The proposed "Wilderness" area includes most of Reed Creek (GA), where numerous instream habitat improvement structures have been installed and more are scheduled to be installed by the Coalition in September '97. Reed Creek receives no stocking and supports a wild fishery of brown trout and brook trout. The proposed area also includes Pigpen Branch (SC) which needs fish habitat improvement structures. Pigpen also supports a wild fishery of brown trout and brook trout without stocking. The proposed "Wilderness" designation precludes fish habitat improvement work.

The Chattooga River Coalition is opposed to this proposal. The "Wild and Scenic River" corridor is approximately one-third (1/3) of the proposed area and is already well protected.

Speaking for the SC TU Council, I encourage you to write the Forest Supervisors in both Georgia and South Carolina. This is very important, PLEASE take the time to write.
