WORK PROJECT/CAMPOUT SCHEDULED FOR SEPTEMBER

The work project at the mouth of Reed Creek will take place on September 26, 1998. Cover logs and other habitat improvement structures are on the schedule. This will also be a good time for a campout on Friday the 25th and maybe even the 26th. We'll cover more of the details at the August meeting when, hopefully, Dave Deavers, USFS, will be on hand to fill in the details. To get to the project site just head on down Hwy 28, pass the turnoff to Burrells Ford. As you go down the hill towards the bridge over the Chattooga, look for a FS road on your left (It is normally closed and gated). Turn there and continue to the end of the road at the large open fields on your right. Unless you are the first one in there, you'll see us. SHOCKING THE CHATTOOGA

PETA GOES AFTER THE NATIONAL PARKS

"The People for the Ethical Treatment of Animals (PETA) have taken up a new cause-they're trying to end fishing in national parks. They have scientific proof, they say, that a hooked fish suffers unspeakably, and true to their organization's mission, they are demanding an end this *torture for sport*." Perhaps we fishermen provide some of the fodder for this bunch of extremist. Releasing trout safely isn't difficult. First of all, using barbless or debarbed flies and hooks makes it much easier to slip the hook from the fish's mouth and in the cases where it has taken the hook deep, it's a neccesity. Also, play the fish as quickly as you can and bring him to net before he is totally exhausted. Often you do not even have to lift the fish from the water just run your hand down the leader and tippet and slip the hook out. If you must pick the fish up, using a net is a big help, providing a less slippery grip and allowing you to keep the trout in the water before lifting him up. When releasing the larger trout, cradle him in your hands, supporting him from beneath. Gently rock him side to side to get the water circulating through the gills. Usually, he'll take off when he's ready.

If you are going to keep a fish, it might be more humane to kill it prior to dropping it in the creel. That flapping you hear minutes later is not a dance of joy but the last gasps for "breath" - not a pleasant way to die.



Replacing Felts on Wading Boots

You can do this yourself, or let a knowledgeable shoe repair shop handle it for you. If you go the do-it-yourself route, I suggest you use contact cement and apply the felts under pressure with clamps or in a vise.

The real advantage to having a pro do this, is they will both glue and stitch the felts on. This results in a longer lasting sole. One such shoe shop is the "Country Cobbler" in downtown Cornelia. The owner is a fly fisherman and is active in the Foothills Chapter of TU. I think there is another such shop in Franklin, but I have no name

to pass on.

New felts give you a more secure feeling when wading and before you know it, fall will be here and the water will begin to cool off. Taking a spill in the summer can be refreshing; in the fall or winter, it can definitely cool off your fishing and in some cases be downright dangerous. Just look up Hypothermia!

TROUT MANAGEMENT PLAN

Thanks to **Lee Keefer**, Fisheries Biologist, Georgia DNR, for meeting with us in July and outlining the state's plan for a new Trout Management Plan. While they plan to gather information from trout fishermen through a telephone survey, Lee welcomes comments via mail. Some thoughts from his presentation: Should we stock private trout waters? Should we reduce stocking schedules in the hot months and increase in the Fall? Should we increase stocking in the most popular fishing areas? Do you want more, but smaller trout stocked?
