# PLANS FOR THE OCONEE-CHATTAHOOCHEE NATIONAL FOREST ENTER A CRITICAL STAGE

Unless you are into fishing for sculpin and stone rollers, you should consider attending one or more of the workshops and input meetings conducted by the USFS. The purpose of these meetings is to concentrate discussion on issues in the proposed "rolling alternative", and to seek common ground on these issues.

The first of these meetings will be held at the Ramada Inn, Clemson, SC on Monday & Tuesday, October 18th & 19th, beginning at 6:00 PM and running to 9:00 PM. The first night will be informational, giving background and context for where the USFS is in the planning process and explaining the "rolling alternative". Through concurrent breakout sessions the issues will be sorted to determine if the USFS is on target or if the "rolling alternative" needs more work.

The 2nd Day workshop will consist of in depth discussions, based on the 1st day results.

The Saturday Meeting is designed to conclude work those areas where substantial agreement might obtainable with more public dialogue. A discus-

sion of those issues where additional analysis and information are needed before substantial public agreement could be sought for how the Rolling Alternative is responding to these issues or whether it does not appear that any common ground can be found.

Input meetings are scheduled at various locations in November and December and are designed to fine tune the Rolling Alternative.

These meetings and workshops are extremely important if we as outdoor sports men and women are to have a voice in managing the National Forests. There are groups who will be in attendance and who have little, if any, interest in the effects the management plan will have on hunting and fishing. If at all possible, try to make the Clemson workshop. If you need a ride over, give a call to either Doug Adams 743-2158 or Tom Landreth 746-2295 and maybe we can all go together.

### SALMO TRUTTA NEEDS A TRIM

There are a whole bunch of Brown Trout at the Burton Hatchery that are in need of a trim before they take their helicopter ride to the Chattooga River.

Lee Keefer, Georgia DNR, will be hosting this yearly event on Friday, October 29th, beginning at 9:00 AM. If you need more than a trout filled Chattooga in the year 2000 as an incentive, the hatchery staff will be cooking hamburgers for us shortly after

11:00. So plan now to come on over to the Burton Hatchery on the 29th. If you simply can't make it on that date, Lee and the staff could use some help the day before, Thursday the 28th at 9:00 AM.

If you haven't clipped fins before, the hatchery supplies the nippers. You should come prepared for cool weather and cold water on your hands as you nip that adipose fin. No experience necessary.

An entertaining conservationist? A good story teller? My gosh...I've just described LeRoy Powell! Maybe that's our problem. Anyway, give it some thought.

#### The Theme and Emphases of the Rolling Alternative

Forest ecosystems would be maintained and restored to ensure healthy watersheds; provide for sustainable and diverse ecosystems; support viable plant, wildlife and fish populations; and to provide for high quality recreational opportunities.

- 1 Maintain healthy watersheds and degraded watersheds would be restored, to maintain or improve water quality and quality habitats.
- 2 Habitats for those species needing large, contiguous forested landscapes would be maintained or increased; and there would be suitable habitat conditions to maintain populations of those vertebrate species native to the planning area. Management action would be taken where needed to conserve and re-

- cover threatened, endangered, sensitive and locally rare species.
- 3 With few exceptions, inventoried roadless areas would be managed to retain their unroaded character. All inventoried roadless areas will be considered for Wilderness recommendations based upon the evaluation of the potential wilderness criteria. Outside of the inventoried roadless areas, there may be some unroaded areas that could become recommended for Wilderness. All rivers eligible for consideration as Wild and Scenic Rivers would be managed to protect their "outstandingly remarkable values."
- 4 A spectrum of high quality, naturebased recreational settings would be

provided. There would be an emphasis on providing those recreational opportunities that are not widely available on non-Federal lands, such as opportunites in non-motorized settings with high quality landscapes. The acres of land providing semi-primitive and non-motorized recreational opportunities would remain the same or increase from the amount currently inventoried. The scenic and aesthetic values of the National Forest lands would be protected or enhanced.

- 5 A variety of large, medium and small old growth patches would be managed to meet biological and social needs. All existing inventoried old growth patches would be protected and there would be appropriate land allocations to ensure an adequate representation of those old growth forest communities found on National Forest lands. The rare communities found on National Forests would be protected or restored. All existing Special Management areas would continue with their existing management direction. Additional areas may be identified for Special Management land allocations.
- 6 The health of forest vegetation would be improved by replacing off-site species, thinning overstocked stands, and restoring fire-dependent and fire-associated communities. Where appro-

- priate and consistent with the values for which the forest is being managed, risks to forests from wildfire, insect and disease damage, and exotic or non-native invasive plants would be reduced.
- Wood products would become available as a result of applying silvicultural activities to achieve the desired composition, structure, and function of forest ecosystems. The rate implementing these activities would be such that a stable supply would be available to the local industries over time.

A minimum transportation system would be available that improves access for forest road users while protecting forest resources. Generally, access will be limited to those areas that can be accessed by maintaining or reconstructing existing system roads, or through the construction of temporary roads. New permanent roads would only be constructed in a few situations. The pace of decommissioning unneeded roads, (both classified and unclassified) would be accelerated.
