Planning Continues on Your Forests

While the new U. S. Forest Service's planning process covers many areas, the two concerns that have emerged as critical to maintaing a viable trout fishery in the Chattooga River are those of wilderness and white water boating.

The two day workshops in Clemson and Gainesville have given the public a chance for their input. The boating interests and the preservationist viewpoints have been expressed and while in a minority most of the time, the fishermen have made their presence known.

Enclosed in this newsletter are two letters that only need to be signed and mailed to the addressees. If you agree with the positions stated in the letters, please follow up by mailing them. If they are not exactly as you would phrase them, use them as a guideline and write your own. But it is very important to get your views known as soon as possible.

In today's Atlanta Constitution, (November 30th), on the editorial page, there is reference to a public hearing in Atlanta regarding the Forest Service's land management plan and the need for public input. While the writer does not specifically mention "wilderness", she urges readers to speak up against logging and roadbuilding and underscores the need for preservation of out natural resources.

Sounds good but what she is probably advocating is hands-off, lock it up and throw away the key management of the resource.

So, make your views known...even if they differ from those in the enclosed letters.

For the next few weeks the Rabun Chapter will be concentrating on the Rabun Rendezvous. After the first of the year we will try to condense all of the comments and directions of these meetings to bring you up-to-date.

Soil Runoff in Rabun County

Not too surprising that rural Rabun County ranks in the top ten Georgia counties when it comes to granting variances from the regulations that are supposed to protect our rivers and streams.

Sitting on the committee that was formed to study the problem and report to the Georgia State Assembly are **Locke Glenn** of Dillard and **Bobby Welch** of Clayton. Yes, the same Bobby Welch that is a developer and Rabun County Commissioner. Mr. Glenn is also involved in development.

The committee has adjourned for the time

being, not able to come to any agreement on the stream buffer regulations. You may also recall that last year, the DNR

removed several streams from the official "trout stream" list...that way the buffer is reduced to as little as 25' instead of the 100' required on "trout streams".

Of course, if you are building in Rabun County, you just apply for a variance and it is likely that you will be granted one. Thanks to the **Clayton Tribune** for bringing the problem to the attention of citizens of Rabun County.
