DNR SUBMITS RECOMMENDATIONS TO USFS ON WILDERNESS PLANS FOR THE FOREST

The Rolling Alternative, USFS Land Management Plan, proposes 33,861 acres of additional wilderness in the Chattahoochee National Forest. The Wildlife Resources Divsion (WRD) has recommended designating 25,000 acres for wilderness and other protected forest prescriptions while maintaining access and wildlife management options in other areas.

David Waller, WRD Director says, "In late January, the Board of Natural Resources passed a resolution directing us to review the Rolling Alternative and develop recommendations for the Forest Service that would provide for wildlife management and recreation access, but that also would meet some of the expectations of wilderness advocates. We have made a good faith effort to find some middle ground in this proposal without sacrificing access for hunters, anglers and campers, and without giving up areas important for wildlife management."

Wilderness is just one of about 30 land classifications or "prescriptions" used by the U. S. Forest Servie to determine the type of management activities permitted on a specific section of the forest. Tracts of forest land that are proposed for wilderness designation are permanently set aside and may eventually be officially declared to be wilderness areas by the U. S. Congress. In a wilderness area, natural processes are permitted to occur without human intervention. A hands off, no management strategy is used. All roads in wilderness areas are closed, and access is restricted to non-mechanized methods such as foot travel or horseback. In addition, wildlife management activities, such as maintaining wildlife openings, stocking trout streams, prescribed burning, and timber thinning are not typically allowed. In the 749,550 acre Chattahoochee National Forest, there currently are about 114,600 acres (15%) in wilderness areas and another 33,900 acres (5%) in protected designations such as National Recreational Areas or National Scenic Areas. Other protected areas surround the Appalachian Trail and the Chattooga River.

In developing the recommendations to the USFS, WRD worked to minimize the impact of additional wilderness on state-operated wildlife management areas and trout streams by redrawing boundary lines and selecting less restrictive prescriptions for sections of various state wildlife management areas. Over 10,000 acres were recommended for other protective classifications such as National Recreation Areas or National Scenic Areas. Less restrictive prescriptions were suggested for the remaining acreage. The Kelly Ridge Area near Hiawassee would be placed in a new National Recreation Area. The Mountaintown Creek Tract near Blue Ridge would be classified as proposed wilderness, except that the creek itself and key roads and wildlife openings in the Cohutta Wildlife Management Area would be outside the new wilderness boundary.

WRD has a long history of managing USFS lands in the Chattahoochee NF, dating back to the '30s. Currently, WRD operates 11 wildlife management areas (WMAs) totaling 314,500 acres, and is responsible for the management of 1,350 miles of trout streams that occur on national forest lands. WMAs are used not only by hunters and anglers, but also by campers, birdwatchers, wildlife photographers, and other outdoor users. WRD, along with the USFS, also maintains wildlife openings, conducts controlled burns, stocks trout streams, builds stream improvement structures, maintains access roads and manages the forest in other ways to benefit both game and nongame species and to provide wildlife related recreation.

David Waller says, "We have worked with wilderness advocates, conservation groups, local citizens, state legislators, and others in developing our recommendations.....", and further, "the ultimate decision, of course, lies in the hands of the Forest Service".
